Software Technologies**


This Memorandum of Understanding (hereinafter called as the 'MoU') is entered into on this the 21st day of February 2023 by and between.

CLAUSE 1


CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish co-operation.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities.
- 1.3 The parties shall co-operate with each other and shall as promptly as is responsibly practical, relevant agreement.

CLAUSE 2

SCOPE OF THE MoU

- 2.1 Industrial Training & Visits: Industry and Institution interaction will provide an insight into the latest developments / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs for the First Party. CLAUSE 3

VALIDITY

3.1 This Agreement will be valid for 5 years from the date of signing of this agreement.

3.2 This agreement will be valid only at the intentions of the parties involved therein, this MOU could be dissolved or cancelled by either party any time by giving 30 days notice and shall not have any legal bindings in nature. Should either or all parties to it opt to not act upon, the MOU loses its validity.

CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name to make any representation or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of the MOU to make agreements of any kind in the name of or binding upon the other party to pledge the other Party's credit, or to extend credit on behalf of the other Party.


